

COVID-19 Liability Release Waiver

Signature Required Upon Pickup

Due to the 2019-2020 outbreak of the novel Coronavirus (COVID-19), The Wine Line, LLC is taking extra precautions with the care of every guest to include a quick health history review and enhanced sanitation/disinfection procedures in accordance with the SLO County Department of Public Health guidance.

Symptoms of COVID-19 include:

- Fever
- Fatigue
- Dry Cough
- Difficulty Breathing
- Muscle pain
- Sudden loss of smell and/or taste

I agree to the following:

- 1. I understand the above symptoms and affirm that I, as well as all household members, do not currently have, nor have experienced the symptoms listed above **WITHIN THE LAST 14 DAYS**.
- 2. I affirm that I, as well as all household members, have not been diagnosed with COVID-19 **WITHIN THE PAST 30 DAYS**.
- 3. I affirm that I, as well as all household members, have not knowingly been exposed to anyone diagnosed with COVID-19 WITHIN THE PAST 30 DAYS.
- 4. I affirm that I, as well as all household members, have not traveled outside of the country, or to any city considered to be a "hot spot" for COVID-19 infections **WITHIN THE PAST 30 DAYS**.
- 5. I understand that The Wine Line cannot be held liable for any exposure to the COVID-19 virus caused by misinformation on this form or the health history provided by any other guests.
- 6. I accept all responsibility for my participation in this tour and hold The Wine Line harmless should I be diagnosed with COVID-19 following this tour.

The Wine Line is following these enhanced procedures to prevent the spread of COVID-19:

- We have mounted plexiglass dividers inside two of our vans between each bench row, and the driver area, to help suppress the potential for any possible aerial contamination.
- All drivers have been issued masks and instructed to wear them at all times.
- Hand sanitizer dispensers have been mounted to the interior of the vans, or dispensers are available.
- Face coverings will be provided to all customers that don't have their own.
- Drivers will thoroughly clean and sanitize upon tour prep, throughout the day (including passenger seating areas, seatbelts and fasteners) and at the end of the day.
- All drivers will be tested for COVID and have been advise not to work if they, or anyone they've been in recent contact with, has any symptoms or diagnosed with COVID, obviously.
